

SPIRITUAL BATTERIES RECHARGED

Last month's 'Encuentro de las Americas' was a true learning community. People from Argentina, Paraguay, Colombia, Peru, Costa Rica, Brazil, USA and the First Nations of Canada met at Sitio Sao Luiz in Petropolis. We analysed the situation in our different countries, sought the roots of spiritual growth and examined case studies linking the moral and spiritual dimension with effective action.

Dra Heyde Duran, a well known Colombian lawyer, outlined the action she and her MRA colleagues are taking amidst critical national issues. On her return home she faxed us: 'To be with you all helped me to confront the way we have been working, individually and collectively. We must work for REPENTANCE as much as for forgiveness.'

A Paraguayan journalist, Cecilio Melgarejo Gomez, representing the Mayor of the country's second city, Ciudad del Este, asked to have an MRA seminar in the city in the coming months. Ed Burnstick of the Cree Nation, from Alberta, Canada, spoke of the contribution of indigenous peoples to the spiritual rebirth the world needs, and this started discussion about a meeting of indigenous leaders on this theme.

Ann Jackson, school principal from Minneapolis, USA, described what she is doing to make community life a source of dignity, respect and well being.

On the last day of the Encuentro, the delegates were joined by community leaders from Rio. Jones Santos Neves Filho, formerly Federal Congressman and Vice-President of the Brazilian Confederation of Industry, spoke about the recent MRA-inspired 'clean election campaign' and of the fight against corruption in Brazilian business. A code of ethics for small businesses is now being distributed in every state, he said.

Other speakers were Luizant Mata Roma, President of the 150,000 strong Commercial Workers Union of Rio, Lucia Maria Nazareth of the Rio Federation of Women's Associations and Tibor Sulik, member of the Vatican Commission for Justice and Peace.

Luiz Pereira and others led discussion on improving the situation in the favelas (shanty towns). Several favela leaders spoke. 'Our contact with MRA has changed our lives,' said Raymundo, President of the Agricola Community Residents' Association. 'If you are able to forgive, you can go through any barrier, including corruption and drugs.' During the following days some of us were invited to visit favela

communities which the local government is transforming into liveable neighbourhoods, with the full cooperation of the inhabitants. In areas where there had been open-air sewers we saw clean, newly-paved streets; where there had been floods, we saw the human touch in flower pots and small parks. 'I was always sure God had a plan for us,' said one of the leaders.

Antonia Galliccio, an educator from Buenos Aires, summed up the Encuentro. 'We have problems in our country,' he said. 'Here we have found a new vision and recharged our "spiritual batteries" to do what is needed.'

GANDHIJI REMAINS 'A MIRROR TO INDIA'

Last month Rajmohan Gandhi was interviewed on BBC Radio 4's leading religious affairs programme, *Sunday*, about the scattering of the remaining ashes of the Mahatma in the River Ganges. Asked how much of a living symbol Gandhi is today in India, Rajmohan replied that while much of what Gandhi believed has been rejected, 'Gandhi remains very much part of the Indian conscience. He was like a mirror to India and he still remains a mirror, even though Indians sometimes want to run away from what they see.'

Asked what Gandhiji would make of Indian society today, Rajmohan replied: 'He would be glad that the Indian Constitution, and Indian laws, ensure that the poorest Indian has some rights; and that every Indian is equal in rights and opportunities to every other Indian, no matter what his or her religion or gender. These are two wonderful things that Indian society honours and sometimes practises.'

We come at the task from different angles, but at heart we all have the longing that each one who comes this summer will find new, honest and creative ways to look at themselves and their part in God's creation.

It is not a time for those who are 'gifted' to develop their skills, but it is for anybody who wants to explore new sides of his or her human nature.

The session will centre on creative workshops in fields as varied as contemplative movement, story telling, clowning, puppet theatre, flower arrangements, 'sports and the creative factor', creative living, etc.

As an integral part of the day everyone will do 'creative community work', i.e. serve, cook, wash-up, prepare beds, etc.

Though some present in Oxted are prepared to make the support of these facilitators a priority when they are in Caux, we feel a great need for international input. If you are considering offering yourself for this support role, Thomas Bräckle would be glad to hear from you so we can coordinate our efforts.

It became clear that those present felt that more training in various fields would enhance our effectiveness, not least in the area of counselling.

We made a number of recommendations for the Consultation in Australia, particularly on training.
